RE: CITY OF CAPE CORAL FALSE ALARM REDUCTION ORDINANCE

Adopted at regular council meeting the 13th day of December 2004, an ordinance amending the City of Cape Coral Code of Ordinances, Chapter 12, Offenses and Miscellaneous Provisions, Article II, Offenses Creating Nuisances, by repealing Sections 12-13 through 12-13.7 and establishing a new section 12-13, to provide regulations for alarms, providing severability and an effective date.

This ordinance provides for Alarm Permit Fees, False Alarm Penalties and sets forth requirements for Alarm Monitoring Companies, Alarm Operators and Alarm System Contractors monitoring, servicing, or residing within the municipal boundaries of the City of Cape Coral which encompass the following zip codes: 33904, 33909, 33910, 33914, 33915, 33990, 33991, and 33993.

All alarm monitoring companies, which for purposes of this letter shall include alarm contractors performing alarm monitoring functions, shall register annually after January 1, for the calendar year with the Police Department. Failure to register annually with the Police Department may result in a \$125.00 fine and/or other administrative action against the alarm monitoring company. Each registration shall be valid for the calendar year. The Police Department shall charge a registration fee of \$125.00 for the calendar year regardless of when during the calendar year the registration occurs. The alarm monitoring company shall provide the following information:

- a. the name, telephone number, and current mailing address to include any forwarding addresses necessary to receive correspondence; and
- b. in an electronic format as specified by the City of Cape Coral False Alarm Reduction Unit, the names, street addresses and telephone numbers of all alarm operators contracted with, within the territorial jurisdiction of Cape Coral; and
- c. the procedure used to verify the legitimacy of an alarm prior to notification of the police department
